

PRIVACY POLICY

AOPL is committed to respecting your privacy and protecting any personally identifiable information that you provide to AOPL. Except as indicated below, AOPL will not sell, rent or share any personally identifiable information that you provide without your consent.

Collection of Non-Personally Identifiable Information

Our web servers automatically capture non-personally identifiable information including, but limited to, your domain name, the IP address of the web page from which you enter our site, the pages that you visit on our site, the click-through rates, and the amount of time that you spend here. However, the individual user will remain anonymous. We may use and analyze this data for trends and to improve our site. Any non-personally identifiable information that we give to third parties will be provided in aggregate form only.

Collection of Personally Identifiable Information

When you engage in activities such as registering for events or to order various AOPL publications, you may be required to submit personal information to AOPL. This information may include data such as your name, company name, address, phone number, fax number, and e-mail address. If you choose not to provide the information that is requested by AOPL, you may continue to visit the site but you may be unable to access certain offers, services, or secure pages. AOPL will not provide any personally identifiable information to any third parties without your consent.

Disclosure to Third Parties

AOPL reserves the right to provide personally identifiable information to third parties if AOPL reasonably believes that this release of information is necessary: 1) To comply with legal requirements or legal process; 2) to protect and defend the rights or property of AOPL; or 3) to protect the other users of the site or the public. Personal information will only be shared by AOPL to improve our services to our members, and it will not be shared with third parties for their marketing purposes. It may be necessary – by law, legal process, litigation, and/or requests from public and governmental authorities within or outside your country of residence – for AOPL to disclose your personal information. We may also disclose information about you if we determine that for purposes of national security, law enforcement, or other issues of public importance, disclosure is necessary or appropriate. We may also disclose information about you if we determine that disclosure is reasonably necessary to enforce our terms and conditions or protect our operations or users. Additionally, in the event of a reorganization or merger, we may transfer any and all personal information we collect to the relevant third party.

Privacy with Respect to Minors

AOPL does not knowingly collect or use information from children under the age of 13 without the consent of a parent or guardian.

Cookies

When you visit our web site, we may place a cookie on your computer that will allow us to track your visit to our site and help us to improve the site. The cookies will not provide AOPL with any personally identifiable information about you. If you wish to disable cookies, you must do so in your preferred web browser.

Although our site has industry standard security measures in place to protect the loss, misuse and alteration of the information that is under our control, AOPL cannot guarantee complete security.

Access to Personal Information

You can help ensure that your contact information and preferences are accurate, complete, and up to date by signing in to your AOPL member login. For other personal information we hold, we will provide you with access (including a copy) for any purpose including to request that we correct the data if it is inaccurate or delete the data if AOPL is not required to retain it by law or for legitimate business purposes. We may decline to process requests that are frivolous, jeopardize the privacy of others, are extremely impractical, or for which access is not otherwise required by local law.
